



Land area | Thousand km²




Population | Millions, 2017




EUR, billions, current prices, 2017




Exports | Goods, EUR, billions, 2017

Internet | Users, as a percentage of total population, 2016








Land area | Thousand km²





GDP per capita | USD, in PPP, current prices




Inflation | Consumer Price Index, year-on-year percentage change

As a percentage of GDP




Note: PPP – Purchasing power parity. A form of currency conversion alternative to market rates. It rests on the comparison of prices in local currency for the same representative basket of goods in different countries (to establish a parity between the purchasing power of the same amount of currency in each country). Frequently used in international comparisons.



Ranking position




Business environment |




Note: Human Development Index: composite indicator calculated by the United Nations Development Programme (UNDP), which takes into account life expectancy, educational attainment and income (1: maximum – 188: minimum in 2010; 1: maximum – 189: minimum in 2017).


Note: Doing Business Indicators: range of indicators relevant to the business environment regulatory framework, compiled by the World Bank. A composite indicator is calculated to encapsulate the overall quality of the business environment in each country (1: maximum – 185: minimum in 2010 and 2017).

Note: Global Competitiveness Indicator: composite indicator calculated by the World Economic Forum, which encapsulates a wide set of macroeconomic and structural indicators seen as relevant for measuring competitiveness (1: maximum – 139: minimum in 2010; 1: maximum – 137: minimum in 2017).


Life expectancy | At birth, years



Literacy rate | Adult population (15+) able to read and write, as a % of total population




Internet | Users, as a percentage of total population

20th anniversary of the Exchange Rate Agreement between Portugal and Cabo Verde (1998-2018)



Inflation: Consumer Price Index (CPI), average annual rate of change.

Fiscal balance/deficit: overall public budget balance/deficit, as a percentage of GDP.

Public debt: foreign and domestic, as a percentage of GDP

Unemployment: average annual rate, as a percentage of total economically active population.

International reserves: net, in months of imports of goods and services.

Exports: of goods and services, as a percentage of GDP.

Openness to trade: exports plus imports of goods and services, as a percentage of GDP.

Foreign direct investment: as a percentage of GDP.





Notes

Life expectancy at birth: total (female and male), in years.

Fertility rate: average number of live births per woman.

Age dependency ratio: number of people below 15 or above 64 years of age, as a percentage of people of working age.

Official development assistance: net, as a percentage of Gross National Product.

Infant mortality: number of children deceased before completing one year of age, per 1000 live births.

Access to electricity: number of people with access to electric power, as a percentage of total population.

International tourists: number of non-residents admitted to the country, staying for less than one year, in thousands.

Internet users: as a percentage of total population.

Mobile phone users: number of active pre-paid and post-paid subscriptions (in use over the past quarter), as a percentage of total population. Fisheries production: total caught or farmed, in thousands of metric tons.
