<u>Scope</u>: Implementation of 10 change requests and resolution of 4 bugs (may be subject to changes).



Change Requests

Number	Description
T2S-0772-SYS	Export of T2S cash transactional data from the Data Warehouse to a Eurosystem's monetary policy application
T2S-0774-SYS	T2S Recovery Solution 2: Rebuild (Rebuild settled data based on settlement confirmations and reprocess incoming messages to recover reference data changes, unsettled instructions and maintenance instructions)
T2S-0775-SYS	IBM Air-gap solution: functionalities and tools needed for the selection and restore of the snapshot in case of T2S Recovery
T2S-0776-SYS	Network Service Providers (NSPs) inbound and outbound traffic retrieval
<u>T2S-0792-SYS</u>	T2S alignment to ISO 10962:2021 CFI code – removal of decommissioned codes
<u>T2S-0797-SYS</u>	T2S should support cross-border settlement via alternative Security CSD Links
<u>T2S-0800-URD</u>	Harmonisation of floor/ceiling notifications with CLM, RTGS and TIPS T2S should be aligned with CLM, RTGS and TIPS in what concerns the floor/ceiling notification functionality, by sending just one notification once the floor or ceiling is breached. T2S should not send the notification again if, after breaching the floor/ceiling, the balance of the T2S DCA remains consistently below the floor or above the ceiling threshold defined.

Number	Description
T2S-0805-SYS	The monthly billing process should not be blocked when a party does not have the invoice configuration
T2S-0810-BFD	T2S should verify whether the certificate used to sign non-repudiation of origin (NRO) is linked to the user initiating the signature
T2S-0814-SYS	Internal operational monitoring tools enhancements

Bugs (PBI)

Number	Description
PBI000000231707	[T2S SDD-PBR-106] [FI] Validation for E2E-ID length for DKK LTs not triggered
PBI000000232058	[SDD-CN-128] Minimum Reserve Calculation=No, Interest Calculation=Selection Made (e.g. Monthly), PSL - Minimum Reserve Obligation = NO. Triggers BRDCC1431 however this set up should be accepted.
PBI000000232192	Double reporting for failing link with ST Already Matched
PBI000000232959	DPU1005 error code raised




